Sub: Incorporation of the additional conditions in the permissions already granted by this Directorate under Regulation 34(6) and 34(4) of the Metalliferous Mines Regulations – Reg.

Dear Sir(s),

In addition to previously permissions already granted to you under Regulation 34(6) & 34(4) of the Metalliferous Mines Regulations, 1961, if any, the following additional precautions shall be complied with strictly:

- 1. The Owner shall pay a **reasonable salary** to the manager and all the statutory persons appointed and the same shall be paid **through bank only**, to have a proof of payment. Ministry of Labour and Employment desires the payment of wages to all work-persons also be paid through bank.
- 2. Wet drilling shall be done by directing a water jet on to the tip of the cutting edge of the ergonomically designed drill machine to prevent dreaded disease silicosis. The jack-hammer drill machines shall be ergonomically designed to minimise harm from vibration and noise.
- 3. Airborne dust survey as provided in Regulation 124(3)(a) shall be done to ascertain the concentration of respirable dust in the air and also to know the percentage of free silica in the dust generated at the mine.
- 4. On or before the 01<sup>st</sup> day of February in every year, Owner/Agent/Manager shall submit Annual Return in respect of the preceeding calendar year ONLINE through website: Shram Suvidha portal <a href="https://shramsuvidha.gov.in">https://shramsuvidha.gov.in</a>

5. Henceforth, all applications for permissions required from this Office shall be submitted ONLINE through website: dgms.gov.in.

You are requested to note and comply.
