# MINUTES OF ANNUAL GENERAL MEETING 2019-20

The Annual General Meeting (AGM) of Mines Safety Association Karnataka (MSAK) was held on 09.11.2020 at 11.30 AM. Shri. Muralidhar Bidari, Director of Mines Safety, Bengaluru Region and Shri. Umesh M. Sawarkar, Director of Mines Safety, Ballari Region who are the patrons of the association were present. Shri Gyaneswar Kondabattini, Dy. Director of Mines Safety, Ballari Region and Shri. Venugopalaswamy Kadem, Dy. Director of Mines Safety, Bengaluru Region were also present. Dr. Meda Venkataiah, Chairman, presided over the meeting. Shri Dhananjaya G. Reddy, Hon. Secretary and Shri P.Suresh, Treasurer were present during the meeting.

## QUORUM

The Chairman called for the attendance who are attended through video conferencing platform and after taking count of members and confirming the quorum for the AGM, called the meeting in order.

## WELCOME ADDRESS:

The Hon. Secretary welcomed Shri. Muralidhar Bidari, DMS, Bengaluru and Shri. Umesh M. Sawarkar, DMS, Ballari and other DGMS officials. He welcomed Dr. Meda Venkataiah, Chairman, Executive Committee Members, Mine Owners, Senior Officials, Zonal Secretaries, VT Managers of GVTC's and all the Senior Executive present in the Annual General Meeting. He said that due to Covid-19 pandemic AGM is being organized on Virtual Platform. He requested the Chairman to preside over the function.

In his opening remarks Chairman welcomed on behalf of MSAK all DGMS officials, Members, Executive Committee Members and Executives present in the virtual meeting. He informed that DGMS role is most important to our association. DGMS officials are guiding and supporting the association for the past 50 years. He also remembered Shri. S.N.Mitra and Shri. S.C.Mohanty, the then Manager of HGML for their contributions and services rendered to the development of MSAK. In view of the Covid-19 pandemic, the entire world is in a grip of monumental public health crisis as well as concomitant acute economic and humanitarian distress. Hence, we are holding the AGM on a virtual platform.

He expressed that with the present situation it may not be possible to conduct mines safety week celebration, we may explore the possibility of conducting some trade test like Foreman, Mine Mate, Mine Blaster, Fitter and Electrician through online. Again, the zones will play an important role in conducting the trade tests and he said it will be left to the zones to decide and organize the same.

Chairman appreciated M/s. R. Praveen Chandra, Chitradurga for their elaborate arrangement of Zone-III & State Level Final day function of "Mines Safety Week Observance 2019-20 at Chitradurga. The stage arrangement and entertainment were a special attraction of the function. He expressed that Mr. Dhananjaya G. Reddy has taken special interest in conducting safety week celebration function in a grand way. The Chairman praised Mr. R. Praveen Chandra and their staff for successfully organizing the function.

## CONDOLENCES:

The Hon. Secretary informed the sad untimely demise of Shri Kamlesh V. Patel, Joint Secretary, MSAK. MSAK condones the unfortunate passing away of Shri Kamlesh V. Patel. He was a simple, caring, active and jovial person and involved in all the affairs of the association wholeheartedly. His passing away is a great loss to the MSAK in general and Zone-2 in particular.

The Hon. Secretary also informed and expressed deepest condolences for sad demise of Shri. N.R. Sidnal, Mine Owner, Lokapura and Shri B.D. Katti, Mine Owner, M/s Sandeep Minerals who has also passed away recently. Shri. Basavaraj Chennappa Udapudi, Mine Owner, Lokapur has also passed away on 13.06.2020. He was the President for Mine Owners' Association of Bagalkot & Belgaum. Hon. Secretary expressed the condolences to departed souls and emphasized that is a great loss to the Zone-II in particular.

The Hon. Secretary requested all the members who were joined in the virtual meeting to observe two minutes silence as a mark of respect to the departed souls and accordingly it was observed.

### 1. CONFIRMATION OF THE MINUTES OF AGM FOR THE YEAR 2018-19:

The Hon. Secretary informed all the members that the Minutes of the AGM has been circulated previously and also it has been circulated along with the Annual Report through email to all the members on 06-11-2020. ### 4. PRESENTATION AND ADOPTION OF AUDITED ACCOUNTS FOR THE YEAR 2019-20

# a. PRESENTATION OF AUDITED STATEMENT OF ACCOUNTS OF MSAK FOR THE YEAR 2019-2020

Shri. P. Suresh, Treasurer, presented the audited accounts of MSAK (Headquarters) with detail explanations. Gross Receipts & Payments for the year ending 31<sup>st</sup> March 2020 were Rs.26,42,642/- & Rs.23,56,295/- respectively, with net excess of income over expenditure of Rs.2,86,347/. The assets MSAK Headquarters as on 31.03.2020 is Rs.71,87,084/-. The same was approved unanimously by the members.

## b. PRESENTATION AND ADOPTION OF AUDITED STATEMENT OF ACCOUNTS FOR THE YEAR 2019-2020

Shri. P.Suresh, Treasurer, presented the audited accounts of MSAK has a whole for the year 2019-20 with detailed explanations for approval of the AGM. Gross Income & Expenditure for the year ending on 31<sup>st</sup> March 2020 was Rs.50,75,470/- & Rs.52,87,767/- respectively, with net excess of expenditure over income of Rs.2,12,297/-. The assets of MSAK (including 4 zones) as on 31.03.2020 is Rs.90,53,165/- and the amounts have been kept either in the form of fixed deposits &/or respective bank accounts.

The financial statements i.e. the Balance Sheet as on 31<sup>st</sup> March 2020 & the Income & Expenditure Accounts for the year were adopted unanimously by the members present in the AGM after detail discussion.

The audited accounts was unanimously accepted and passed as proposed by Shri.K.Ramani and seconded by Shri K.Madhusudana, Secretary, Zone-I.

### 5. ELECTION OF JOINT SECRETARY FOR THE PERIOD 2020-21:

Shri. Dhananjaya G. Reddy, Hon. Secretary, informed the gathering about necessity of electing Joint Secretary for the remaining term of 2019-21. After detail discussions, Mr. Ramanna M. Jumanal proposed Mr. G.S. Narasimha Murthy for the post of Joint Secretary, seconded by Shri. Dhananjaya G. Reddy and was unanimously agreed by the members present in the AGM.

The Hon. Secretary, informed the gathering that Mr.J.P. Kumar, Executive Committee Member has left the organization and he may be outside the country and asked the Zone-3 representatives to nominate any active member as executive committee member representing Zone-3. The Chairman informed that the person should be either Executive Committee Member of MSAK at Zonal Level or at State Level and not at both the places. After details discussions Mr. N. Randive, Secretary, Zone-3 proposed Mr. Ganesh Murthy's name for Executive Committee Member and unanimously agreed with the consent of DGMS officials of Bengaluru Region.

# 6. APPOINTMENT OF AUDITOR FROM THE CONCLUSION OF THIS AGM TO THE CONCLUSION OF NEXT AGM:

As per RULE-15, an external auditor to audit the financial statements of the Association is required from the conclusion of this AGM to the conclusion of next AGM. Shri. Dhananjaya G. Reddy, Hon. Secretary informed the gathering that M/s. Satyam & Dutta, Chartered Accountants, Hosapete are retiring auditors are eligible for re-appointment. The members have unanimously agreed to re-appoint M/s. Satyam & Dutta, Chartered Accountants, Hosapete to carry out the functions as auditors of MSAK at remuneration to be fixed by the Executive Committee.

# 7. DISCUSSIONS ON TO FINALISE THE SAFETY WEEK CELEBRATIONS FOR THE YEAR 2020-21

The Hon. Secretary requested the DGMS officials to through light on conducting the Trade Test competition and Inter Mines Competitions. Shri Venugopala

Swamy, DDMS Bangaluru suggested that all mines can send soft copies of videos, records, safety preparations, plans and sections of their workings and accordingly we can judge for awarding the prizes. The Chairman said that it is very difficult to judge the performance and award prizes in this manner, since all the mine managements may send only good videos.

Shri Umesh M. Sawarkar, DMS, Bellary said that this year it may be difficult to conduct Inter Mines Competition, however we can take a call in the month of December on this issue. However, he said that possibility of conducting online Trade test may be explored. The Chairman proposed to conduct few trade tests like Foreman, Mate, etc., through online but expressed that we cannot do practical test. Group Vocational Training Centers may explore the possibility of organizing online test both at state and zonal level. Mr. K. Madhusudana, Secretary, Zone-I, said that conducting online trade test is not possible because of internet connection issues in some of the mines located in remote areas. The Chairman sought the guidance of the DDMS, Ballari and Bengaluru for possibility of conducting online trade tests as per DGMS guidelines. Shri Gynaneswar, DDMS Bellary and Shri K Venugopala Swamy, DDMS, Bangaluru have agreed to study the possibility of conducting online Trade Tests.

Shri. Muralidhar Bidari, DMS, Bengaluru said that at present situation, it may not be possible to conduct inter mines competitions and said that we have to wait for some more time. He said that we may wait for one more month and in the month of December we may take a call on this issue. He also suggested to train and create awareness on The Occupational Safety, Health and Working Conditions Code, 2020 to the workers and supervisory staff in all the zones of MSAK.

Mr. S.S.Nayak suggested that we can conduct inspection of inter mines through Drone Cameras but it will be very expensive.

#### 9. ANY OTHER MATTER WITH PERMISSION OF THE CHAIR

#### a. PRINTING OF WALL CALENDARS:

The Chairman briefed that free distribution of the wall calendars with safety slogans may be continued this year also. This is part of publicity and propaganda. For printing of calendar some budget is required. We can collect this amount through sponsorship by printing sponsors name in the wall calendar and all have agreed for the same.

#### b. FOREMAN COMPETENCY EXAMINATION:

The Hon. Secretary informed that the applications of the candidates applying for Mine Foreman's examination are being rejected on wholesale basis even with minor deficiencies by DGMS and requested Shri Muralidhar Bidari, DMS to address the issue, since he was involved more in conducting DGMS examinations. Shri. K. Madhusudhana, Secretary, Zone-I, briefly informed that DGMS, Dhanbad is conducting Foreman's (Restricted) examination, which will be held on 29.11.2020. Some of the applications are rejected due to deficiency in Character Certificate, Affidavit, Medical Certificate are not in prescribed format, etc. This will be a loss of one year for candidates who have applied. He requested DMS, Bengaluru Region to facilitate with DGMS, Dhanbad to liberally consider their application for appearing for examination. Shri Muralidhar Bidari, DMS, Bengaluru Region assured that he will take up the matter with the Examinations section at Dhanbad and will try to solve the issue.

The meeting concluded with vote of thanks proposed by Shri Dhananjaya G. Reddy, Hon. Secretary.

The results of the inter mine competitions are yet to be declared by respective Director of Mines Safety Offices.


In Covid 19 pandemic situation, MSAK made efforts to observe the mines safety week and conducted webinar on interested topic.


# WEBINAR ON CRISIS MANAGEMENT

# SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNTS

#### 1. Background

Mines Safety Association Karnataka (MSAK), is a Public Charitable Association and carries out its activities on "No-Profit basis". MSAK was set up in late sixties to aid the Directorate General of Mines Safety (DGMS) in spreading the message of safety & health & well-being of workers in the Mines.

MSAK is registered under the Karnataka Societies Registration Act, 1960 vide Society No. BLY-S372-2014-15, dated 27.02.2015 with the Registrar of Societies, Bellary District, Bellary.

MSAK was also registered under section 12A(a) of the Income tax Act, 1961 vide F. No. CIT(E)BLR/ITO(E)-3/12A/GLB-771/AADAM8942M/2015-2016, dated 28-01-2016 and has also obtained approval under section 80G(5)(vi) of the Income tax Act, 1961 vide F. no. CIT(E)BLR/ITO(E)-3/80G/GLB-771/AADAM8942M/Vol 2015-2016, dated 28-01-2016.

The main objects of MSAK are to spread awareness about safety and safe operations amongst the workers, staff, and others in the mining industry.

The executive committee has the overall responsibility for the general control, administration and management of the activities of MSAK.

MSAK operates through its zones with its registered office at Hosapete, Ballari District, Karnataka.

During the year due to COVID-19 pandemic the Association could not undertake its major event i.e. Safety Week Celebrations as was done in the past. Nevertheless, MSAK organized seminars or workshops through online mode.

## 2. Statement of significant accounting policies

## (a) Basis of preparation

The financial statements i.e. the Balance Sheet as at March 31, 2021 & the Income and Expenditure Account for the year then ended, have been prepared in accordance with the Indian Generally Accepted Accounting Principles ("GAAP") under the historical cost convention on the Cash basis of accounting.

The financial statements have been prepared on the going concern concept.

## (b) Recognition / Accounting of voluntary contributions, income & expenses

Receipts from donors with a specific direction have been considered as donations meant for such activities and also utilized &/or shall be utilized towards such activities. Receipts such as subscription amounts from members, enrolment fees from new members, if any, are considered as income in the current year (excluding taxes). Similarly the expenses are recognized on the basis of actual payments of the same (excluding eligible input tax credits).

Interest income is recognized as and when such interest amounts are credited to respective fixed deposit bank accounts &/or on actual receipt of the same.

## (c) Fixed deposits with banks / Deposits

Fixed deposits with banks are intended to be kept for long term basis (> 12 months) & hence are not considered as part of current assets.

## (d) Income tax

MSAK is registered under section 12AA of the Income tax Act, 1961, hence the income of the Association is exempt from tax subject to compliance of terms and conditions specified therein.

MSAK has preferred appeals to the Commissioner Income tax (Appeals) on account of tax levied by the department for financial year 2016 - '17 (Assessment year 2017 - 18) and consequently has paid Rs. 210,730 as deposit with the said authority and the Association is confident of getting a favourable order from Commissioner Income tax (Appeals).

(e) Adjustments to Capital fund – GST electronic credit and cash ledger balances as availed &/or deposited and made available on the GST portal are taken cognizance and reconciled and the same are considered as an adjustment to the capital fund as at year end.

- (f) In the opinion of the Executive Committee of MSAK, the amounts shown in the Balance Sheet are reflected at their realizable values, unless stated otherwise.
- (g) Figures have been rounded off to the nearest rupee value.
