PRESENTATION OF AUDITED STATEMENT OF ACCOUNTS OF HEAD QUARTER FOR THE YEAR 2021-22.

Mr. P. Suresh, Treasurer, MSAK, presented the audited accounts of MSAK (Headquarters) for year 2021-22 with detail explanations. Gross Receipts & Payments for the year ending March 31,2022 were Rs.23,96,985/- & Rs. 19,77,591/- respectively, with net result of excess of income over expenditure of Rs.4,19,394/-. The assets of MSAK Headquarters as on 31.03.2022 is Rs.82,13,496/-. The same was approved unanimously by the members.

PRESENTATION OF AUDITED STATEMENT OF ACCOUNTS FOR THE YEAR 2021-2022

Mr. P. Suresh, Treasurer, presented the audited accounts for the year 2021-22 of MSAK Association as a whole, with detailed explanations for approval of the AGM. Gross Income & Expenditure for the year ending March 31, 2022 was Rs.60,69,043/- & Rs.45,17,539/- respectively, with net result of excess of income over expenditure of Rs.15,51,504/-. The assets of MSAK as on 31.03.2022 is Rs.1,09,22,996/- and the amount has been kept either in the form of fixed deposits &/or in the respective bank accounts.

The financial statements i.e., the Balance Sheet as on March 31, 2022 & the Income & Expenditure Accounts for the year were unanimously accepted by the members present in the AGM after detail discussion. "Outgoing Chairman and Honorary secretary will be ex-officio for a period of 2 years"

Annual Report 2022-2023

MSAK is an apex association in spreading the safety awareness in Karnataka & other states. The association has its continuous service to the mining fraternity with great zeal and enthusiasm in strengthening the industry which is the backbone for the nation's industrial growth.

MSAK is organizing inter mines competitions, by conducting safety weeks, final day functions etc, in all 4 zones with objectives to inculcate the Safety awareness among the Mining Community in particular and common public in general with updated safety standards and mines rules & regulations.

MSAK has conducted inter mines competitions and Trade Tests in all four zones and member mines participated in Safety Week Celebration during the year 2022-23 and the details are as follows:

Zonal Activities:

Activities of MSAK, Zone-I – 2022

- 1. The Mines Safety Association Karnataka, Zone-1 Celebrated Mines Safety Observance Week 2021-22by involving all the Mines and Stone Quarries of Ballari, Chitradurga, Davanagere District and some part of Andhrapradesh.
- 2. Zone-1 Annual General Body Meeting was heldon19.09.2022, Monday@Hotel Malligi, Hosapete.
- 3. MSAK, Zone-1 initiated the Safety Week by organizing 28 trade tests from 15.10.2022 to 28.10.2022 and First-Aid was conducted separately on 8th November 2022among 32 Iron Ore Mines. In these Trade tests total 868 employees were participated and 151 prizes were distributed. 2nd and 3rd prizes were distributed after completion of trade tests at venue itselfand 1st Prizes were distributed at final day function celebration at SurabhiKalyanaMandira, Amaravathi, Hosapete on 30.11.2022.

Participation: During the year 2021-22, under Zone-1, 32 Iron Ore mines in Bellary district and 141 Granite Quarries of Ballari, Davanageri, Chitradurga district & Anantapur district of Andhra Pradesh have participated. Participation of No.of granite quarries increased by 10 this year due to lot of efforts from DGMS, Ballari office, Ballari

We have divided participating mines in to 6 groups, Namely Mechanised-A1, Mechanised A2, Mechanised-A3, Mechanised-A4, Mechanised B1, Mechanised B2, and Semi Mechanised Granite Quarries divided into 3 groups as Semi mechanized—C1, C2 and Semi Mechanised—C3.

Inspection: The inspections of these mines were conducted between from 21.11.22 to 25.11.22.Total 24 inspection team members from different Cement & Iron Ore companies have inspected all participating mines of this zone and evaluated themas per DGMS suggestions giving emphasize to safety. On 30.11,2022 Zonal level final day function was organized at Surabhi Kalyana Mantapa, Amaravathi Hosapete, In this event 1st prizes for all Trade Tests have been distributed and prizes among the mines were distributed by the dignitaries on the dais. This year Zonal level function was hosted by M/s.V.N.K. Menon and M/s. M. Hanumanth Rao jointly. They have celebrated the Final day function in a grand manner right from reception of guests, and by arranging deleicious lunch, cultural activities etc. MSAK, Zone-1 appreciates & express sincere thanks to the both M/s.V.N.K. Menon and M/s. M. Significant Accounting Policies and Notes on Accounts

1. Background

Mines Safety Association Karnataka (MSAK), is a Public Charitable Association and carries out its activities on "No-Profit basis". MSAK was set up in late sixties to aid the Directorate General of Mines Safety (DGMS) in spreading the message of safety & health & well-being of workers in the Mines.

MSAK was also registered under section 12A(a) of the Income tax Act, 1961 vide F. No. CIT(E)BLR/ITO(E)-3/12A/GLB-771/AADAM8942M/2015-2016, dated 28-01-2016 and has also obtained approval under section 80G(5)(vi) of the Income tax Act, 1961 vide F. No. CIT(E)BLR/ITO(E)-3/80G/GLB-771/AADAM8942M/Vol 2015-2016, dated 28-01-2016. Both the registration & approval under section 12A(a) or 12AB and under section 80G(5)(vi) of the Income tax Act, 1961, respectively, have been subsequently renewed for a period of five (5) years w.e.f. financial year 2021 – 22.

The main objects of MSAK are to spread awareness about safety and safe operations amongst the workers, staff, and other personnel in the mining industry.

The executive committee has the overall responsibility for the general control, administration and management of the activities of MSAK.

MSAK operates through its zones with its registered office at Hosapete, Vijayanagara District, Karnataka.

During the year and aftermath of COVID-19 pandemic, the Association could undertake its major event i.e. Mines Safety Week Celebrations as was done in the past along with conduct of National Conference at Bangalore in physical mode.

2. Statement of significant accounting policies

(a) Basis of preparation

The financial statements i.e. the Balance Sheet as at March 31, 2023 & the Income and Expenditure Account for the year then ended, have been prepared in accordance with the Indian Generally Accepted Accounting Principles ("GAAP") under the historical cost convention on the cash basis of accounting.

The financial statements have been prepared on the going concern concept.

(a) Recognition / Accounting of voluntary contributions, income & expenses

Receipts from donors with a specific direction have been considered as donations meant for such activities and also utilized &/or shall be utilized towards such activities. Receipts such as subscription amounts from members, enrolment fees from new members, if any, Income from conduct of conferences, etc. are considered as income in the year of reciept (excluding taxes). Similarly the expenses are recognized on the basis of actual payments of the same (excluding eligible input tax credits).

Interest income is recognized as and when such interest amounts are credited to respective fixed deposit bank accounts &/or on actual receipt of the same.

(b) Fixed Assets and depreciation

During the year the Association has purchased computers (laptops) – 2 nos. and the same has been capitalized in the books of accounts. Depreciation has been calculated in line with the provisions of the Income tax Act, 1961 on WDV method. The details are as hereunder:

(a) Fixed deposits with banks / Deposits

Fixed deposits with banks are intended to be kept for long term basis (> 12 months) & hence are not considered as part of current assets.

(e) Income tax

MSAK is registered under section 12AA/12AB of the Income tax Act, 1961, hence the income of the Association is exempt from tax subject to compliance of terms and conditions specified therein.

MSAK had set apart Rs. 461,061 towards acquisition of land and building for its office at its head-quarters i.e. Hosapete, Karnataka since financial year 2017 – '18 (Assessment year 2018 – '19) and the same had to be spent within a period of five (5) years for the said amount to remain untaxed i.e. upto end of the current year. Due to disruption in activities of the Association owing to novel COVID-19 pandemic during the preceding years, the set apart amount could not be spent for the intended purpose within a period of five (5) years and therefore MSAK has charged Rs. 10,975 to the income and expenditure account as income tax of prior period during the current year.

(f) Adjustments to Capital fund – GST electronic credit and cash ledger balances as availed &/or deposited and made available on the GST web portal and other adjustments are taken cognizance and the same are considered as an adjustment to the capital fund as at year end.

- (a) (g) In the opinion of the Executive Committee of MSAK, the amounts shown in the Balance Sheet are reflected at their realizable values, unless stated otherwise.
- (h) Figures have been rounded off to the nearest rupee value.
