The Annual General Body Meeting (AGM) of Mines Safety Association Karnataka (MSAK) was held at 11.30AM on 12.06.2017. Shri Manish E. Murkute, Director of Mines Safety, Ballari Region and Patron of MSAK was present, Shri H.G. Shreepada, Vice Chairman presided over the meeting in the absence of Chairman, Dr. Narendra Kumar Nanda, Dr. Meda Venkataiah, Hon. Secretary, Shri Prakash Treasurer, were present during the meeting.

#### Quorum

The Vice Chairman called the attendance register signed by all the attendees and after taking count of member and confirming the quorum for the AGM, called the meeting in order.

#### Welcome Address:

The Hon. Secretary welcomed the Members present in the Annual General Meeting.

#### Presentation of Accounts for the Year 2016-17

Dr.Meda Venkataiah, Hon. Secretary, MSAK, Presented the audited accounts of MSAK (Headquarters) and National conference with detail explanations. Gross receipts & Payments for the year ending March 31, 2017 were? 38,88,764/- & ? 22,15,833/- respectively, with net result of excess of income over

expenditure of ? 16,72,931/-. The assets of MSAK Headquarters as on 31.03.2017 is ? 51,68,517/- The same was approved unanimously by the members present in the meeting.

#### Appointment of Auditors of MSAK

The meeting also appreciated and congratulated all the organizers, authors, member mines and all other who have contributed directly and indirectly for their efforts to make the National Conference on "Innovative, Safe & Sustainable Mining" at J.N. Tata Auditorium, Indian Institute of Science on 3rd & 4th June-2016 under the aegis of Directorate General of Mines Safety (DGMS), Supported by Geological Society of India & MEAI Chapters of Ballari-Hosapete, Bangalore & Hutti-Kalaburgi.

There being no other points to be discussed in the AGM, the meeting ended with vote of thanks by Dr. Meda Venkataiah.

MSAK is organizing inter mines competitions, by conducting safety weeks, final day functions etc, in all 4 zones with objectives to inculcate the Safety awareness among the Mining Community in particular and common public in general with updated safety standards and mines rules & regulations.

MSAK has conducted inter mines competitions & Trade tests in all four zones and member mines participated in Safety Week Celebration during the year 2017-18 and the details are as follows:

#### Golden Jubilee year Celebrations:

The Mines Safety Association was established in the year 1968 by late Shri S.C Mohanty of Hutti Gold Mines Company Limited with its office at Hutti. In its long journey MSAK spread its wings into pan Karnataka and later into the Ballari DGMS jurisdiction areas of Ananthapur and Kurnool districts of Andhra Pradesh were included into its fold. After the formation of Bangalore Regional office of DGMS the Krishnagiri District of Tamilnadu was brought under the jurisdiction of MSAK.

MSAK is organising Inter mines competitions, Workshops, Training programmes, Seminars, etc., from time to time to bring the latest technology, developments in mining field, information, etc, to the mining fertility.

Since 2018 will be the Golden Jubilee year of its existence, the Mines Safety Association Karnataka has decided to celebrate the occasion by organising a two day National Seminar at Bangalore in the month of May 2018.

#### **ACHIEVEMENT OF MSAK**

The Association since its inception has contributed immensely in the development and propagation of science and technology in all spheres of mining industry. Noteworthy contributions of the Association include holding of National Seminars on several contemporary topics of importance. The Association is successful in bringing the academicians, researchers, professionals and equipment suppliers on to a single platform where the technology and expertise related aspects are discussed in detail. The Zones are also engaged in conducting short-courses, training programmes, workshops to the mining fraternity.

The Association continues to strive forward to strengthen the competitiveness of the professionals working in the mining industry and assumed to play a vital role in the economic development of the mining and mineral industry in the country. Some of the noteworthy efforts put forward in year 2017-18 are as follows.

#### **Zonal Activities:**

#### Zone-I

Mine Safety Week Celebration 2017: about 31 Iron Ore mines in Bellary district & 40 Stone Quarries & 1 Iron Ore mine of Anantapur district of Andhra Pradesh have participated. Participation of No. of granite quarries increased drastically this year due to lot of efforts from DGMS, Ballari office.

Participating mines were divided into 6 groups, Namely Mechanised-A1, Mechanised-A2, Mechanised-B1, Mechanised-B2, Semi Mechanised-C1 and Semi Mechanised-C2.

The inspection of these mines were conducted between 21st to 27th of October, 2017. About 16 inspection team members drawn from different cement

companies have inspected all participating mines of this zone and submitted their reports. Final day function was held on 29.10.2017 at Surabhi Kalyana Mantapa, Hosapete.

Trade test Details: 28 trades tests were conducted for this year. There was Good response from all Mines. Around 155 workers/employees were declared winners and they have received the prizes accordingly. 13 Teams have participated for Shuttle cock competition, 8 teams were participated in First aid competition and 15 teams participated for Quiz. Around 45 judges from various Organizations have supervised these competitions.

#### Zone-II

The Annual General meeting of MSAK Zone-II was held on 31st May 2017 at Bagalkot. Shri Manish E. Murkute, DMS, Ballari Region, presided over the meeting.

Shri G.S. Narasimhamurthy, Secretary, Zone II, Shri L S. Hiremath, Treasurer, Zone II, Shri Shantakumar Mine Manager, M/s. HGML, Mine Owners, Executive Committee members, and mine managers of member mines were present.

Shri G.S. Narasimhamurthy, Secretary, welcomed one & all to the meeting. Joint Secretary Shri B.S. Muarli presented the statement of accounts/ Audit report for the year 2016-17 & was passed unanimously. As per decision of MSAK, the Mines Safety Week celebrations in zone-II was to be observed from 4th Dec 2017 to 9th Dec 2017 & to be concluded with State Level Final day Award Presentation Ceremony on 10th Dec 2017 hosted by M/s. HGML at Hutti.

Shri Manish E. Murkute, DMS, Ballari region, emphasised on 'Swatch Bharat Abhiyaan' at every Mines & asked to include 'Swachhata prize' for participating mines for their best performance.

Silicosis Awareness Programme along with Medical Checkups for Koppal district mine workers was conducted in the first week of June 2007. Around 43 Member Mine Workers of Granite sector were examined in the event.

MSAK Zone II Executive Committee meeting was held on 19th Sept 2017 to chalk out the action plan for Inspection & Trade Test programme of Mines Safety Week 2017.

Different trade tests for mine workers at zonal level was held from 25th Oct 2017 to 31st Oct 2017 in Bagalkot and Ilkal area mines. Accordingly 10 different trade test were conducted in 8 different mines in the zone. About 120 mine workers and supervisory staffs apart from underground workmen have participated. Underground trade test were conducted at Hutti Gold Mines and 220 workers had participated.

Totally about 90 mines participated in mines safety week celebration 2017 of Zone –II covering different minerals like Gold, Limestone, Dolomite, Granite, Iron ore and Quartz. Six inspection Teams were formed to inspect the mines, each team headed by senior managers from different companies drawn from other Zones.

The Zonal and State level final day function was held on Sunday, 10th December 2017 at 9-00 AM at HGM Institute, Hutti, Raichur dist.

#### Zone-III

Annual General Meeting of MSAK Zone-III was held on 08.06.2017 at 11.30 AM at the Tomatina Hotel, HSR Layout, Bengaluru. Shri. S. K. DAS, Director of Mines Safety, Bengaluru Region presided over the meeting.

The DMS suggested that rolling shield prize should be discontinued and replaced with crystal type prizes from this year onwards. Accordingly rolling Shield has been replaced by Acrylic Prizes.

Further, the second prize amount for the trade test winners has been revised to Rs. 500/-instead of Rs. 250/- which was being paid earlier. #### **Report on Financial Statements**

We have audited the accompanying financial statements of Mines Safety Association Karnataka (MSAK), Hosapete, Ballari District, Karnataka, that comprises the Balance Sheet as at 31st March 2018, the Income & Expenditure Account for the year then ended and the annexed significant accounting policies.

## Management's Responsibility for the Financial Statement

The Management i.e. the Executive Committee of MSAK is responsible for the preparation of these financial statements that give a true and fair view of the financial position and financial performance of the Association (MSAK) in accordance with the Accounting Standards generally accepted in India. #### SIGNIFICANT ACCOUNTING POLICIES

#### 1. Background

Mines Safety Association Karnataka (MSAK), is a Public Charitable Association and carries out its activities on "No-Profit basis". MSAK was set up in late sixties to aid the Directorate General of Mines Safety (DGMS) in spreading the message of safety & health & well-being of workers in the Mines.

MSAK is registered under the Karnataka Societies Registration Act, 1960 vide Society No. BLY-S372-2014-15, dated 27.02.2015 with the Registrar of Societies, Bellary District, Bellary.

MSAK is also registered under section 12A(a) of the Income tax Act, 1961 vide F. No. CIT(E)BLR/ITO(E)-3/12A/GLB-771/ AADAM8942M/2015-2016, dated 28-01-2016 and has also obtained approval under section 80G(5)(vi) of the Income tax Act, 1961 vide F. no. CIT(E)BLR/ITO(E)-3/80G/GLB-771/ AADAM8942M / Vol 2015-2016, dated 28-01-2016.

The main objects of MSAK are to spread awareness about safety and safe operations amongst the workers, staff, and others in the mining industry.

The executive committee has the overall responsibility for the general control, administration and management of the activities of MSAK.

MSAK operates through its zones in the states of Karnataka, Andhra Pradesh & Tamilnadu with its registered office at Hosapete, Ballari District, Karnataka.

## 2. Statement of significant accounting policies

## (a) Basis of preparation

The financial statements i.e. the Balance Sheet as at March 31, 2018 & the Income and Expenditure Account for the year then ended, have been prepared in accordance with the Indian Generally Accepted Accounting Principles ("GAAP") under the historical cost convention on the Cash basis of accounting.

The financial statements have been prepared on the going concern concept.

## (b) Recognition / Accounting of voluntary contributions, income & expenses

Receipts from donors with a specific direction have been considered as donations meant for such activities and also utilized &/or shall be utilized towards such activities. Receipts such as subscription amounts from members, enrolment

fees from new members, if any, are considered as income in the current year. Similarly the expenses are recognized on the basis of actual payments of the same.

Interest income is recognized as and when such interest amounts are credited to respective fixed deposit bank accounts & /or on actual receipt of the same.

## (c) Fixed deposits with banks / Deposits

Fixed deposits with banks are intended to be kept for long term basis (> 12 months) & hence are not considered as part of current assets.

## (d) Income tax

MSAK is registered under section 12AA of the Income tax Act, 1961, hence the income of the Association is exempt from tax subject to compliance of terms and conditions specified therein.

(d) Figures have been rounded off to the nearest rupee value.
